# 2. Usage:

The software comes installed into Amazon EC2 AMI's found into the AWS Marketplace. The server applications (services) can be installed only as specified by the provider using Amazon AWS AMI from the AWS Marketplace according with the recommended AMI types (see the installation guide here https://www.my-drive.cloud/services.html).

Files found into next sub-folders and recurring folders are Q-Bis Consult copyright.

You can not copy or move the software solution to other server instances (AWS EC2 AMI) or to another computers outside the Amazon AWS.
